Pain points

Reporting & Steering Layer

- Large number of data points and key figures (quantitative and qualitative) subject to external audit
- KPI calculation vs. pre-defined KPIs from source systems
- Consideration of disclosure management for report creation and XBRL tagging

Data Management Layer

- Harmonisation of data in a central data model
- Consideration of overall IT strategy
- Availability of central data lake / data warehouse

Data Collection Layer

- Data collection from different source systems
- Sufficient data quality & granularity needed at different provision frequencies
- Handling with data gaps (missing input data)
