Grower update – 1 November 2013 This update relates to Gunns Plantations Woodlot Schemes 2000 to 2006, 2008 & 2009 (GPL Woodlot Nominated Schemes) (Excludes the Great Southern Schemes)

1. Grower Woodlot insurance

On 30 September 2013 we provided an update to Growers of the Gunns Plantation Woodlot Schemes advising that, whilst we were continuing to negotiate with insurance providers, there remained risk that insurance coverage may not be available to Growers.

Growers may be aware their woodlot insurance (where applicable) for Gunns Plantation Woodlot Schemes 2000-2006, 2008 and 2009 is due to expire on 30 November 2013.

Since our last update the GPL Liquidators have been in on-going discussions with insurance providers regarding insurance renewal options for Growers. However, following these discussions, we note it is unlikely insurance providers will offer insurance to Growers.

Should insurance providers decline to offer insurance, Growers are ultimately responsible for maintaining their own insurance.

Whilst GPL will continue to endeavour to arrange an offer of insurance for Growers, GPL and its Liquidators are not responsible for any losses arising as a result of the trees not being insured.

Options that Growers may wish to consider include:

- 1. Arrange for your own insurance
- 2. Elect not to obtain insurance.

Ultimately, Growers will need to decide, having regard to their own circumstance and risk appetite, as to which option to pursue. In doing so, Growers may wish to consider obtaining their own independent advice.

Should insurance providers be in a position to offer insurance to Growers, we will communicate this to Growers accordingly.
