# **Grower update – 26 September 2016**

### This update relates to Gunns Plantations Woodlot Schemes (the Schemes)

- the Australian Taxation Office (ATO) ruling relating to the GST treatment of the net sales proceeds to be distributed to Growers
- distribution timeline and process.

### 1. Taxation compliance

As advised in our email update dated 8 September 2016, the ATO was aiming to publish the final GST class ruling on 15 September 2016.

We confirm that the final ATO GST class ruling (CR 2016/64) was received on 15 September 2016 and is now available on the following websites:

#### **GST** class ruling

The ATO has determined that Growers did not make a taxable supply for consideration when GPL, in its capacity as Responsible Entity (**RE**), disposed of Scheme Assets.

This means Growers:

- who are registered for GST, will not have a GST liability after receiving their distribution from the RE
- will not be required to remit GST from their distribution to the ATO; this will be remitted collectively by the RE.

This ruling allows for an efficient payment and distribution process to Growers.

Now that the ATO ruling has been published, we are in a position to commence the distribution process to Growers.
